3 a) The purposes of the processing for which the personal data are intended	Personal data are processed, among others, for the following purposes: <ul style="list-style-type: none">- Processing of services, evaluations and inspections conducted by the employer, such as support requests and audits, employee surveys and employee benefits.- Recruitment and employment relationship management.- Evaluation of personal performance and follow-up of education and training.- Payment of salary or remuneration.- Compliance with the requirements of the Act on Staff Registers (nimikirjalaki) and Decree on Staff Registers (nimikirja-asetus).- Planning and follow-up of use of working hours and resources.- Planning and follow-up of labour costs.- Invoicing based on work done.- The State's statistical and research use.- Government employer's negotiation and agreement activities.- Disclosure of data for the State Calendar of Finland.- Publication of contact information.
3 b) The legal basis for the processing	The processing of personal data is necessary for compliance with a legal obligation to which the National Land Survey is subject and for the performance of a task carried out in the public interest. Employment Contracts Act, State Civil Servants' Act, Act on Staff Registers
4. Categories of personal data subject to processing	National Land Survey's personnel

5. Recipients to whom personal data are disclosed	Data can be disclosed within the limits of the existing legislation. Data is disclosed for instance to <ul style="list-style-type: none">- Tax Administration.- Execution authorities.- Trade organisations.- Employment Relationship Register of Keva.- Customer when the invoicing is based on work done.- Payer's and recipient's bank.- Financiers.- For statistical and research purposes on the basis of agreements related to the Ministry of Finance and Finland's EU membership.- Editors of the State Calendar of Finland.- External service providers for the provision of employee benefits.- Other external service providers for the processing of assignments.
6. Transfer of personal data to a third country or international organisation	Data can be transferred to a third country or an international organisation when the EU Commission has approved the third country or international organisation to provide an adequate standard of data protection. In other cases, the National Land Survey takes care of appropriate safeguards regarding the data transfer.
7. Storage time of personal data	The data will be stored up to date and part of the data is stored permanently in accordance with the National Land Survey information management plan.
8. The legitimate interests pursued by the controller or by a third party (where the processing is based on a pursued interest)	Personal data is not processed for the purposes of legitimate interest pursued by the National Land Survey or by a third party.

9. The rights of the data subject

The data subject has the right to request access from the National Land Survey to personal data concerning himself or herself, that is to check his or her personal data stored in the register in accordance with the EU General Data Protection Regulation. The request shall be sent to the National Land Survey's Registry.

The data subject has the right to request from the National Land Survey a correction without undue delay of inaccurate or incorrect personal data pertaining to the data subject. The request to correct personal data shall be sent to the National Land Survey's Registry.

The data subject does not have the right to request the National Land Survey to remove personal data pertaining to the data subject when the processing of personal data is necessary to comply with a statutory duty, to perform a task in the public interest or in the exercise of official authority.

The data subject does not have the right to request the National Land Survey to limit the processing of personal data pertaining to the data subject when such processing is necessary for the National Land Survey to comply with a statutory duty. The data subject does have the right to request the National Land Survey to limit the processing of personal data pertaining to the data subject when the processing of personal data is based on the performance of a task in the public interest or in the exercise of official authority. The request to limit the processing of personal data shall be sent to the National Land Survey's Registry.

The data subject does not have the right to oppose the processing of personal data pertaining to the data subject by the National Land Survey, when such processing is necessary for the National Land Survey to comply with a statutory duty. The data subject does have the right to oppose the processing of personal data pertaining to the data subject by the National Land Survey when the processing of personal data is based on the performance of a task in the public interest or in the exercise of official authority. The notification of opposition to the processing of personal data shall be sent to the National Land Survey's Registry.

The data subject does not have the right to request the National Land Survey to transfer personal data pertaining to the data subject when the processing of personal data is necessary to comply with a statutory duty, to perform a task in the public interest or in the exercise of official authority.

10. Right to withdraw consent for processing personal data

Personal data is not processed on the basis of the consent of the data subject.

11. Right to appeal to the Data Protection Ombudsman

The data subject has the right to lodge a complaint with a Data Protection Ombudsman, if the data subject is of the opinion that the National Land Survey does not comply with personal data processing legislation.

12. Obligation to submit personal data

The providing of personal data is necessary for compliance with a legal obligation to which the National Land Survey is subject, for the performance of a task carried out in the public interest or for the conclusion of a contract based on consent.

13. Source of personal data

Data is collected directly from the person himself or herself and his or her supervisor or from a person whose duties include planning of working hours and resources at the National Land Survey.

In addition, information is obtained, among others, from the following data sources:

- Personal taxation data are obtained from the Tax Administration.
- Information related to travelling and the use of charge card are obtained from the travel agency and the credit card company.
- Information about the expected retirement age and time, retirement decision and employment time are obtained from Keva.
- Information about recovery proceedings are obtained from the execution authorities.
- Penal information to be registered in the name register are obtained from the court.

14. Automated decision-making and profiling based on personal data in connection with automated decision-making

The processing of personal data does not involve automated decision-making.
